Outside of their practices, our New York attorneys place great importance on advancing pro bono initiatives and giving back to our communities. Our attorneys created one of the first law-firm-run name change clinics, where we assisted 40 clients in 2022 through the daunting process of an application to the court for a legal name change.

The New York office welcomes over 20 law students each summer for the firm’s 10-week summer associate program, which is filled with substantive work, training opportunities, and social functions. Mock negotiations enable summers to play the role of counsel and guide their clients through a merger, and a mock trial features Winston attorneys and staff in the roles of judge, witnesses, and jurors. Program participants get to know each other and experience a taste of the city through a range of activities, from Brooklyn Bowl and the Harlem Jazz Show to a volunteer event at the New York Food Bank.
