Kimball is recognized as one of the “Top 100 Trial Lawyers” in the United States by *Benchmark Litigation US*. He concentrates his practice in the areas of antitrust, patent infringement, class actions, and professional liability litigation.

Having tried cases over a range of issues for more than 40 years, Kimball focuses his practice on complex commercial matters, with specific prowess in consumer class actions, patent litigation, and antitrust investigations. Kimball is a Fellow of the American College of Trial Lawyers.
