DECLARATION OF MARC R. GREENBERG

I, Marc R. Greenberg, declare:

I am an attorney at law, duly licensed to practice before the Courts of the 3 1. State of California. I am Counsel with the law firm of Tucker Ellis, LLP, counsel of record for Ioan Luca ("Defendant" and/or "Luca" in this action. I have personal 5 knowledge of the facts set forth below and, if called as a witness, could competently 6 testify to the following.

2. On Friday afternoon, August 30, 2019, the United States Attorney produced 8 a data CD Rom disk with 360 separate documents, many of them multiple pages, 9 separated into fourteen folders. The documents were supposedly the emails relating to 10 LCDR Bor's March 1, 2019 email. No explanation was provided as to why LCDR Bor's March 1, 2019 email, or the newly produced emails and documents, had not been 12 produced months earlier. 13

3. One of the documents produced on August 30, 2019 is an email from LCDR Stephen Bor to LCDR Tyler Stutin from January 20, 2019, setting forth who must be 15 taken off the ship and detained in the United States. "Is Sector in a position to identify 16 the likely crew members we'd need in the event this case ends up being referred to and 17 accepted by DOJ?" - Response - At a minimum, the mater, C/E and all of the licensed 18 officers, all the oilers, and if the electrician was the one who conducted the weekly tests. 19 A true and correct copy of the email string is attached as Exhibit "A". 20

Another document produced on August 30, 2019 is an email from January 4. 21 25, 2919, between Brian Sale at Customs and Boarder Protection LCDR Stephen Bor 22setting forth the names of the crew members "that shall state within the jurisdiction of the 23U.S. District Court - Central District of California." The list includes Fitter Stefan Bunda 24 and Electrical Engineer George Cadar. A true and correct copy of the January 25, 2019 25email is attached as Exhibit "B." Exhibit "A" and "B" confirms that the crew members 26did not stay in a hotel in El Segundo, California voluntarily and were only allowed to 27 leave at the decision of the United States Attorney after they were interviewed and found 28

to be unhelpful to the government's theory of the case as presented to them by RAC 1 Margelot. 2

5. Conspicuously absent from the documents produced on August 30, 2019 are 3 the emails that RAC Margelot described to LCDR Bor as being written by RAC Margelot 4 to highlight the flaws by the Inspectors – "RAC Margelot indicated that he intentionally 5 wrote the emails in a such a manner that when the USAO drops the case, it will be Sector's 6 fault and not CGIS." (The investigators work for "Sector" and CGIS is the Coast Guard 7 Investigative Service. RAC Margelot is with the CGIS.) 8

On Sunday, September 1, 2019, AUSA Andrew Roche provided Defendants 6. 9 with copies of the sum total of the government's investigation of the statements, 0 allegations and claims of misconduct that were identified in LCDR Bor's March 1, 2019 Email to LCDR Tyler Stutin, CAPT Monica Rochester, CAPT Rebecca Ore, CDR 12 Marshall Newberry, CDR Michelle Bas, LCDR Anthony DeStephano, and DCDR Kyra 13 Dykeman. 14

7. 15 Defendants had asked that the U.S. Attorney use the FBI to investigate the conduct of the Coast Guard rather than allowing the Coast Guard to investigate the Coast 16 Guard. This request was apparently declined because Coast Guard Special Agent Ashley N McKay wrote all of the reports of interview of Agent Margelot, Agent Venable, LCDR Bor and SAC Hoyle. 19

A true and correct copy of the report of the U.S. Attorney's August 30, 2019 8. 20interview of LCDR Bor is attached hereto as Exhibit "C". 21

9. A true and correct copy of the report of the U.S. Attorney's August 28, 2019 22 interview of RAC M. Margelot is attached hereto as Exhibit "D". 23

A true and correct copy of the report of the U.S. Attorney's August 29, 2019 24 10. interview of SA J. Venable is attached hereto as Exhibit "E". 25

A true and correct copy of the report of a phone interview of SAC K Hoyle 11. 26 is attached hereto as Exhibit "F". 27

The investigation of the "snafu" within the Coast Guard reveals that the 12.

management of the Coast Guard, all the way up to the Captain of The Port and Special 1 Agent in Charge knew of the issues but no investigation was conducted. 2

One of the documents included in the August 30, 2019, production is a copy 13. 3 of handwritten notes by Special Agent in Charge Kelly Hoyle from her conversation with 4 CAPT Rochester on February 28, 2019, three days before they both received a copy of 5 LCDR's March 1, 2019 email. Even before reading LCDR's email CAPT Rochester 6 expressed her concerns with RAC Margelot's conduct, attitude and refusal to follow guidance, and refuses to allow anyone speak to the U.S. Attorneys. The end of the note 8 states - "wants new agents assigned." A true and correct copy of the notes written by 9 SAC Hoyle are attached as Exhibit "G". SAC Hoyle, in the US Attorney's August 29, 10 2019, phone interview, stated that "CAPT Rochester never asked SAC Hoyle to remove any agents from the AMAZON case." This is contradicted by SAC Hoyle's own note that 12 reads: "Wants New Agents Assigned." The United States Attorneys did not interview 13 CAPT Rochester in relation to her conversation with SAC Hoyle, or as to what, if any, action she took two days after her conversation with SAC Hoyle when CAPT Rochester 15 read LDCR Bor's March 1, 2019 email. 16

17 14. When Agent Margelot was asked about his interview of the Second Engineer Gavriluta-Strat he stated that he did not feel he was "ever untruthful to the 2/E during the 18 interview. He simply explained the process of how witnesses and subjects with the 19 government work." Perhaps Agent Margelot has forgotten that the interview was tape 20recorded. 21

15. Agent Margelot told Mr. Gavritula-Strat that if he did not say that the order 22 to transfer bilge water to the clean drain tank came from the Chief Engineer Mr. 23 24 Gavriluta-Strat would not talk with his children for as much as a year. He justified this by claiming that in other cases the Coast Guard has seized crew member's phone. This 25of course belies that fact that Mr. Gavriluta-Strat could have purchased a new phone the 26following day. It also overlooks the fact that Agent Margelot told Mr. Gavriluta-Strat 27 that if he would just put the blame on the Chief Engineer, he – Agent Margelot, would 28

personally arrange for Mr. Gavriluta-Strat to have daily video conferences with his 1 children. When that failed, Agent Margelot offered Mr. Gavriluta-Strat the choice 2 between two closed hands. Mr. Gavriluta-Strat could choose one hand – blame the Chief 3 Engineer and be a witness in the case, or choose the other hand and continue with his 4 refusal to blame the Chief Engineer and get prosecuted. Agent Margelot, did not have 5 the authority to make such an offer and he well knew this because the offer violated the 6 Coast Guard's Policies and Procedures for investigation of MARPOL cases. 7

The following day, in a second interview of Mr. Gavriluta-Strat, the Coast 16. 8 Guard, Lt. Phillips, with Agent Margelot, went much further than just lying to try, and 9 failed, to get Mr. Gavriulta-Strat to inculpate the Chief Engineer - he told Mr. Gavriluta-10 Strat precisely what he need to say to earn daily video conferences with his children 11 personally arranged by Agent Margelot. Mr. Gavriulta-Strat had to say that the order to 12 pump bilge waste to Clean Drain Tank came from the Chief Engineer to the Mr. Gavriula-13 Strat and the he in turn gave the order to the 4th Engineer. According to Lt. Phillips – 14 anything less would lack credibility. (January 12, 2019 interview, page 21.) 15

17. Agent Margelot and Lt. Phillips violated the Commandant's Instruction 16 M16201.1 in several ways. No statement is permitted to be made as to the status of the person as a witness, subject or target. Agent Margelot had no legal authority to offer Mr. Gavriluta-Strat the choice between the two hands/options Agent Margelot presented him. But perhaps the most offensive part is that Lt. Phillips told Mr. Gavriluta-Strat precisely what he had to say because anything less and "your credibility will be shot." The Coast Guard, Agent Margelot and Lt. Phillips, were trying to manufacture testimony rather than conduct an investigation. A copy of the complete transcript from the first onboard interview of Mr. Gavriluta-Strat is attached as Exhibit "H", the second interview conducted the following day is attached as Exhibit "I".

If an attorney, prosecuting or defense, where to make such a statement to a 18. 26witness it would be considered to be witness tampering and obstruction of justice. Yet, Agent Margelot finds nothing wrong with his conduct, even with the benefit of hindsight 28

and a transcript of the tape-recorded conversation. This conduct is known to the Agent 1 Margelot's superiors, SAC Hoyle and CAPT Rochester, and yet no internal investigation 2 was undertaken after these issues came to light in March 2019. Nothing was done to 3 investigate Agent Margelot, or his startling allegations of misconduct by others within 4 the Coast Guard. 5

19. The contradictions between LCDR Bor's March 1, 2019, summary report to 6 the CAPT Rochester, and the recent statements by Agent Margelot to the U.S. Attorney 7 on August 29, 2019 are striking: 8

- a. The USAO is threatening to drop the case. Margelot now claims that he never said this.
- b. RAC Margelot was writing emails to blame the Investigators for when the case gets dropped. Margelot now claims that the U.S. Attorney was never threatening to drop the case.
- c. RAC Margelot had to talk the AUSA "off the ledge" from dismissing the case. Margelot now claims he never said this.
- d. RAC Margelot stated that Inspectors admitted to him that they had tainted interview statements. Margelot now claims he never said this.

Now that Agent Margelot's allegations have become an issue for the Court, 20. 18 LCDR Bor has tried to walk-back some of the statements in his March 1, 2019 email. 19 For example, he now states that he wishes he hadn't taken Agent Margelot's comments at face value. Why shouldn't he take seriously the statements of the Resident Agent In Charge (RAC) of the Coast Guard Investigative Service for Los Angeles and Long Beach.

The belated production of documents provides no explanation as to what 21. 23 happened on board the ship the made RAC Margelot threaten to remove his entire 24criminal investigation team, as noted in LCDR Bor's March 1, 2019 email. However, we 25 do know that RAC Margelot attempted to edit reports of Inspectors and deleted any 26 mention of chain of custody or handling of the evidence. He deleted three separate paragraphs from the report of an Inspector that he described as "illiterate 28

kindergarteners". All of the deletions concerned chain of custody of evidence. 1

There is also no resolution of the nature of the "snag" that LCDR Bor now 22. 2 describes as being a "SANFU" (A World War II acronym meaning Situation Normal: All 3 F-ed Up.) For some reason LCDR Bor apparently thinks that SNAFU is less serious than 4 a "snag." The August 30, 2019, production of documents included an email exchange 5 from January 28, 2019 to January 30, 2019 referencing the "snag with the AUSA" 6 regarding one of the Inspectors. This is apparently the "snag" that LCDR Bor now calls 7 a "SNAFU." A true and correct copy of the emails referencing a "snag" are attached as 8 Exhibit "J". The government has not identified the Inspector or the nature of the "snag" 9 / "SNAFU." This will remain a mystery. 10

23. As for statement by LCDR Bor to Coast Guard management on March, 1, 2019, that "RAC Margelot named certain Sector inspectors that, according to 12 him, admitted to tainting evidence in their written statements", the names identified 13 by RAC Margelot and the disclosure of what was evidence and/or statements are tainted 14 also remains a mystery. RAC Margelot denies he ever made the statement. It is highly 15 unlikely that LCDR Bor made the statement up to include in his email to Coast Guard 16 management. Meanwhile, in his interview by the U.S. Attorney, LCDR Bor "speculated 17 that RAC Margelot might have been referring to when CWO Reed turned the reach rod 18 and to see if it was connected." Whether it is merely the passage of time between when 19 RAC Margelot made the statement and when it was finally investigated by the U.S. 20Attorney, or the more likely explanation that no one wants to be blamed for causing a dismissal, what exactly was tainted and my whom within the Coast Guard remains a 22mystery. 23

24 24. The lack of a resolution to what was Inspectors admitted to tainting report of interviews is quite troubling because the statement was documented by LCDR Bor on 25March 1, 2019 and yet no one investigated it, despite the fact that the Chief of the 26Criminal Division and the Captain of the Port learned about the statement as early as 27 March 1, 2019. From March 1, 2019 to August 22, 2019, no one in the Coast Guard took 28

as much as a pause in the action to investigate an allegation that would, in most law 1 enforcement agencies, be a career-ending act of obstruction of justice. 2

25. I have not yet had the time to review all of the newly produced documents 3 from the government. However, the documents reviewed, along with the short interview 4 reports provided, reveal that we do not know the extent of the damage done and we 5 apparently never will, in part because this is an eleventh hour production of discovery 6 and an eleventh and a half hour investigation by of the Coast Guard of the Coast Guard. There is no resolution to the issues noted above and no explanation, whatsoever, as to 8 why these issues were not investigated six months ago, or, why we are only learning 9 about it now, two weeks before trial. 10

I declare under penalty of perjury under the laws of the State of California and the United States that the foregoing is true and correct. Executed on the 4th day of 12 September, 2019, at Los Angeles, California. 13

It's better if you help us to understand what's taking place and why it's taking place than if we have to continue to look and kind of put it together ourselves as we go. It's much better if you just help us to get an idea of what's going on. Is someone telling you to do this? Are you making this decision?

I understand – I can see on your face you're thinking and you're worried. I can certainly understand that. I think you've seen throughout the day – I've worked with you quite a bit today – our main concern is obviously the safety of your crew, your safety was well, and the safety of this vessel. So, can you help us understand why some of those safety items are being missed, why we're seeing items that shouldn't be in an engine room there?

On 08/29/2019, Assistant United State Attorney (AUSA) Paul Stern and AUSA Andrew Roach, US Attorney's Office Central District of California, and I, Special Agent Ashley McKay, CGIS Pacific Region Alameda CA, conducted an interview with Coast Guard Investigative Service (CGIS) Resident Agent in Charge (RAC) Matt Margelot, CGIS RAO Los Angeles-Long Beach (LA/LB) at 312 North Spring Street, Los Angeles, CA.

Below is a summary of events in which RAC Margelot recalled:

During his interview of the Second Engineer (2/E), the evidence known at the time was that the Chief Engineer (C/E) was involved with the illegal discharge. At the time of interview with the 2/E, RAC Margelot said he led the interview in a direction which he could possibly gain an admission from the 2/E and have him acknowledge the C/E's involvement. RAC Margelot wanted to find out what truly happened.

RAC Margelot further explained his thought process, that if the 2/E did have firsthand knowledge of the C/E being involved, he could potentially be another witness for the government. During the interview with the 2/E, RAC Margelot educated the 2/E on the benefits of cooperation.

RAC Margelot said prior to interviewing the 2/E, he already received two statements from two other crewmembers which alleged the 2/E was involved. When he went into the interview with the 2/E he wanted to first, obtain a confession of his involvement and second, if the C/E was involved, he wanted to obtain the information from the 2/E in anticipation of possibly gaining another witness for the government.

RAC Margelot stated he did not feel he was ever untruthful to the 2/E during the interview. He simply explained the process of how witnesses and subjects with the government work. From his experience with these types of cases, RAC Margelot said normally when the government does an extraction of witness and subjects phones they normally return witness's phones but keep the subjects phone. He explained this as a potential benefit of cooperation to the 2/E. RAC Margelot also noted, all of the whistleblowers from this case had their phones returned to them.

When RAC Margelot was asked about the AUSA dropping the case, he said the AUSA never made that statement. He implied a similar statement to LCDR Bor to highlight the importance and significance of having the materials (statements, evidence, photos, etc) from USCG Sector LA/LB. He recalled that following the referral brief on 23JAN, USCG Sector LA/LB had agreed to conduct a turnover of all case materials to CGIS in two weeks. RAC Margelot said it was approximately four to five weeks later when they started to receive the requested items. He further expressed this created pressure on CGIS when the AUSA was making requests which CGIS could not fulfil.

He further explained, there were some "lessons learned" from a previous MARPOL case which he worked that motivated him to create a list of how to improve the process with future cases. He shared this list with Sector personnel via email but said the list was disregarded from the onset of the AMAZON investigation.

RAC Margelot exclaimed his "ultimate goal" was to have a clean presentable package to turnover to the USAO. He had concerns about how the Sector conducted their process and the timing in which CGIS was receiving the needed materials

(statements, evidence, photos, etc). He offered that he had become frustrated with the Sector because at the time (around 19FEB) he was receiving tasking (from AUSA Heather Gorman) to draft criminal complaints for material witness warrants and needed the turnover information to ensure accuracy. He recalled the criminal complaints ultimately did not go anywhere but he has maintained the drafts.

When asked about reviewing Sector personnel's statements, RAC Margelot acknowledged that he did review two statements. He said he conducted a quality control review of the statements, not a substance review. He simply identified verbiage and grammar issues because he did not feel that the authors of the statements proof read them. When asked why he did this RAC Margelot replied, it wasn't his job to do so but he was trying to provide the best possible product to the AUSA.

At the end of February, LCDR Bor came by the CGIS RAO LA/LB office to speak with RAC Margelot. He explained that he was not expecting LCDR Bor but they met in the CGIS conference room and discussed the AMAZON case. He recalled LCDR Bor had demanded to speak directly with the USAO (which he had done four to five times prior). RAC Margelot explained he did not allow him to because it was not his role to do so, CGIS is the conduit to the USAO for criminal investigations. Additionally, he did not feel it would be very professional to have multiple USCG personnel contacting the USAO. It was RAC Margelot understanding that LCDR Bor had previously worked in a legal realm and he felt this might have been one of the reasons LCDR Bor wanted to speak directly with the USAO.

In reference to paragraph 12 of the email sent by LCDR Bor, RAC Margelot did not recall ever saying the AUSA threatened to drop the case of that he had to "talk her off the ledge."

In reference to the email sent by RAC Margelot to LCDR Dykman on 27FEB (RE: AMAZON Turn Over (CS1901000160)), the last line of the email, RAC Margelot said he was simply stating the facts. If the USCG/CGIS could not present the evidence to the USAO we ultimately would not have a case. He reiterated that he was stressing the importance of the process to USCG Sector LA/LB.

In reference to paragraph 12 (page 3) of the email sent by LCDR Bor, the statement about "tainting evidence." RAC Margelot adamantly exclaimed he never stated that any members of the investigation "tainted evidence." He did, however, express concern to LCDR Bor that the personnel which took the evidence and logged it wasn't accurate based off the statements. RAC Margelot stated, "I know for a fact, no one ever told me they tainted evidence."

RAC Margelot recalled tasking S/A Venable, via email, to have ENS Stickey and CWO Reed come over to the CGIS office to swear/sign to their original statements after a phone call he had with District Eleven Legal, LCDR Tyler Stutin.

In reference to paragraph three of the email, the best he could recall, RAC Margelot believed the "snag" was due to a theory of the OCM being tricked, which CWO Reed may have come up with, and AUSA Gorman thought the main issue was the clean drain tank, not the OCM. This was early on in the investigation, he recalled speaking with AUSA Gorman and her having questions which he did not have the answers to because he still had not received Sector LA/LB's reports.

After LCDR Bor sent his email, RAC Margelot recalled he received a phone call from SAC Hoyle asking what was going on between Sector LA/LB and CGIS RAO LA/LB. Prior to the call, he believed SAC Hoyle had received a phone call from the Staff Judge Advocate (SJA) CDR Erin Adler, to also inquire from him what was going on in LA/LB. RAC Margelot was under the assumption that CAPT Rochester may have personally called the SJA which initiated the stream of phone calls but he was not certain.
