Reed was lead counsel for the U.S. in the first successful government price reporting cases against the pharmaceutical industry, involving Medicare and Medicaid Average Wholesale Price reporting (*US ex rel. Ven-A-Care v. et al.*); Medicaid Drug Rebate price reporting (*US ex rel. Ven-A-Care v. et al.*); Medicaid Drug Rebate price reporting (*US ex rel. Foster v. Parke-Davis, US ex rel. Alcorn v. Schering-Plough*); and the Prescription Drug Marketing Act fraud (*US ex rel. Gerstein v. TAP Pharmaceuticals*).
