The Felix Project

Winston's London office is working with the Felix Project this holiday season. The Felix Project is a UK-based food redistribution charity that primarily addresses food waste. Millions of people in the UK regularly experience hunger, yet tons of surplus fresh food is thrown away daily.

The Felix Project distributes 250 tons of food per week (about 20 million meals per year). This surplus food is collected by volunteers and delivered to food banks, homeless shelters, schools, refuges, day centers, and charities. This charity needs extra support at this time—they recently took charge of [FareShare](#)'s London operation.

Thanks to the London team's generosity, Winston raised enough money to provide 1,500 meals to those in need.

The Legal Aid Society

Over the last several years, Winston & Strawn's New York office has partnered with The Legal Aid Society and contributed to their annual holiday party for homeless and other less fortunate children in the community. This year's in-person party is canceled due to COVID-19 restrictions. However, Winston is still supporting the organization's modified efforts by sending toy donations and gift cards for families to purchase food and winter clothing during this very difficult year.
