Nathan's experience in merger review includes preparation of Hart-Scott-Rodino (HSR) filings, analyzing where foreign competition filings may be required, assisting in the coordination of foreign competition filings, analyzing the reportability of transactions under the HSR Act, analyzing the potential antitrust risk of a transaction and responding to government inquiries and Second Requests to obtain pre-merger approval. He also maintains an active antitrust litigation practice where he assists clients in litigating class actions, competitor lawsuits, coordinating settlement strategies, and other complex multidistrict litigations for both plaintiffs and defendants.

Prior to joining the firm, he was a Judicial Extern for the Honorable Timothy J. Kelly in the United States District Court for the District of Columbia, where he drafted orders and opinions and researched legal issues in preparation for oral arguments and orders.
