Amy is a health care fraud and abuse lawyer who draws on her experience as a former attorney in the Office of Counsel to the Inspector General in the Department of Health and Human Services and her years in private practice to provide a unique and practical perspective to companies throughout the health care sector.

Amy focuses her practice on health care regulatory counseling, compliance, and defense. She has extensive experience advising organizations regarding the Anti-Kickback Statute, the Physician Self-Referral Law (commonly known as the Stark Law), the Civil Monetary Penalties Law, and Medicare program requirements. She works with stakeholders throughout the health care sector, including health systems, drug and device manufacturers, and digital health companies to structure compensation arrangements, develop business models, manage internal investigations and government disclosures, and navigate government investigations and enforcement actions under the False Claims Act. Her experience includes value-based care, patient assistance programs, and providing tools, support, and incentives to patients.

After several years in private practice, Amy served as senior counsel in the Office of Counsel to the Inspector General (OIG) at the Department of Health and Human Services. In that role, Amy provided legal analysis and advice to OIG and the Department of Justice (DOJ) regarding the Anti-Kickback Statute and the Civil Monetary Penalties Law in connection with policy development and OIG/DOJ investigations and enforcement actions. She also drafted several OIG Advisory Opinions and represented OIG in associated legal matters. During her tenure, Amy was a member of the team that crafted the new safe harbors for value-based care as part of the Regulatory Sprint to Coordinated Care, and she advised on OIG's guidance modernization initiative.
