Daimiris is an expert in international dispute resolution and focuses her practice on international arbitration, international trade, and cross-border litigation. Her pro bono work is focused on international human rights.

Daimiris joined the firm from Winston's summer associate program. She works closely with financial institutions, public and private companies, and not-for-profits in the technology, manufacturing, client services, and energy sectors.

Her international dispute resolution practice focuses on international arbitrations, compliance with U.S. regulations regarding international trade, and cross-border litigation. Daimiris has advised clients in several countries throughout Latin America, Asia, and the Middle East, and has represented private companies and state-owned entities in commercial and investor-state arbitrations under the rules of the London Court of International Arbitration (LCIA) and International Chamber of Commerce (ICC). She counsels clients on compliance with sanctions or embargoes imposed by the U.S. Department of Commerce's Office of Foreign Assets Control (OFAC), anticorruption/anti-bribery laws, import regulations, and restrictions related to the export of sensitive goods, such as technology, defense equipment, or dual-use products under the Export Administration Regulations (EAR). She also represents clients in all aspects of government criminal and civil investigations and related litigation, including those

led by federal and state enforcement and/or regulatory authorities, including the U.S. Department of Justice, regional U.S. Attorney's Offices, state and federal regulatory agencies, and state attorney general offices.

Daimiris maintains an active pro bono practice in the field of international human rights. She has conducted in-depth analysis of complex international family law issues affecting survivors of domestic violence, published legal articles addressing gendered and criminal Strategic Lawsuits Against Public Participation (SLAPPs), and advocated for tenant's rights in housing court. She has argued for the right of persons deprived of liberty to receive adequate health care before the United Nations Special Rapporteur on the Right to Health and the rights of the LGBTQ+ community to freedom of expression, association, and liberty alongside the UN Independent Expert on sexual orientation and gender identity.

Daimiris is a native Spanish speaker and is fluent in French.
