Newman's appellate and trial experience has ranged over contract, tort, intellectual property, securities, and antitrust matters across various industries and jurisdictions. Key Matters

Some of the experience represented below may have been handled at a previous firm.

- Represented an energy company in an appeal before a Texas state court; obtained reversal of an entry of judgment of \$75 million.
- Represented an out-of-state telecommunications company in an appeal before a Texas state court; obtained reversal of the trial court's denial of a special appearance.
- Represented a Swedish manufacturer in an appeal before a Texas state court; obtained reversal of the trial court's denial of a special appearance.
- Represented a telecommunications company on appeal before the Fifth Circuit; obtained reversal of the trial court's denial of a motion to dismiss raising issues of causation in the context of product liability with critical industry-wide importance.
