Josh is a driven attorney with a unique combination of legal experience, military service, and a commitment to client advocacy.

Before pursuing his legal career, Josh served as a sergeant in the U.S. Army where he held the position of Special Agent, Army Criminal Investigation Division. In that role, he investigated a broad range of matters including procurement fraud, crimes against children, and homicide. At Winston, Josh has applied his skills to False Claims Act litigation, civil and criminal antitrust matters, and various Department of Justice investigations. He has experience preparing expert witnesses for trial and drafting legal memoranda in a broad range of practice areas, including government investigations; bankruptcy; discovery disputes; and commercial litigation. A prolific writer, he has published several law review articles and has prepared client advisories about ongoing CFTC, FinCEN, and SEC enforcement actions. Josh maintains a robust pro bono practice focused on criminal defense, veterans' benefits, and immigration law. In that practice, he has filed appeals before the Second Circuit and worked directly with incarcerated clients.

Josh has also gained invaluable experience through his legal internships and fellowships. At the U.S. Department of Homeland Security, he drafted legal memoranda and appellate briefs regarding matters of national security, fraud, and counterterrorism. At the Center for Appellate Litigation (CAL), he drafted appellate briefs for indigent criminal defendants, re-investigated cases referred by New York's Conviction Integrity Unit, and prepared parole files and clemency applications. He continues working with CAL as part of his pro bono practice.

Along with his professional accomplishments, Josh is passionate about education and advocacy. As a legal writing instructor for the Cornell Prison Education Program, he built curriculum and taught written and oral advocacy to incarcerated students at Cayuga Correctional Facility. He also advocated for and advised clients in Title IX proceedings, including matters of sexual violence, harassment, and protected-status discrimination as lead counselor for the Cornell Office of the Complainants' Codes Counselor.
