She maintains an active pro bono practice, representing incarcerated individuals in habeas appeals and Section 1983 cases, as well as asylum seekers in immigration proceedings. She also advises pro se litigants each month on federal court practice and procedure as part of the U.S. District Court's Hibbler Memorial Pro Se Assistance Program.
