Key Matters

Bailey's notable past engagements include:

- Defended a major financial services company against breach of contract and common law tort claims, obtaining dismissal of all claims on a motion to dismiss
- Obtaining dismissal of consumer fraud claims under the Illinois Uniform Deceptive Trade Practices Act and antitrust claims against a professional specialty board in the Northern District of Illinois on a motion to dismiss
- Defeating class certification in a shareholder class action related to a transaction between a medical device and health care products company where the claims reached over \$1 billion
- Representing a global investment manager against tortious interference, negligent misrepresentation, and state antitrust claims through a trial. The court denied the plaintiffs' request for a permanent injunction
