Scott was a member of the *Alston v. NCAA* team that won a landmark 9-0 victory before the United States Supreme Court in 2021 and the Winston team that in May 2024 obtained a historic multibillion-dollar settlement in *House v. NCAA* that is poised to revolutionize the economic model of college sports. As part of his college sports work, Scott also regularly counsels clients on name, image, and likeness (NIL) laws and policies.

Scott represented the U.S. Women's National Team in its lawsuit against the U.S. Soccer Federation that culminated in a settlement guaranteeing equal pay and working conditions between the men's and women's soccer teams.

Scott also represents numerous sports leagues, sports agencies, and prominent ATP tennis tournaments. On a pro bono basis, Scott has represented two separate Olympic and Paralympic athletes before the Court of Arbitration for Sport in Lausanne, Switzerland.
